No part of the net earnings of Dripping Springs Tennis Association shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this certificate of incorporation.

In the event of the liquidation or dissolution of Dripping Springs Tennis Association, all assets of the corporation remaining after payment of, or provision for the satisfaction of, all liabilities or obligations of the corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose, as determined by the Board of Directors. Such distribution shall be made in accordance with all applicable provisions of the laws of this state.
